#### Grants, Grants, and more Grants!

There are three grants from the Wisconsin Department of Natural Resources which the Lake District has been actively engaged in since our 2017 inception. These grants provide monetary resources to help improve water quality and manage invasive species. In return, the grants require a commitment of time and energy in the form of volunteer effort to educate, monitor changes and take ownership of our shared natural resource, Upper Turtle Lake.

- 1. In 2018 we applied for and were awarded an Education and Planning grant. The total project cost was \$26,700. Our award of \$20,011 represented 75% of the total cost. Information generated through weed bed mapping, herbicide movement (dye study) and turion density allowed for the development of a data-driven, large scale treatment plan for 2019. We were able, through volunteer efforts, to pay for 25% of the cost, without any out-of-pocket District expense. Thank You to all who volunteered!
- 2. In December of 2018 we applied for and were awarded a Clean Boats Clean Waters grant for 2019. This grant was approved for \$4,810, of which 75% is grant reimbursable. Volunteers will be needed for 120 hours of boat landing inspection time, in addition to 80 hours of paid inspection

- time. In 2018 we inspected 279 boats, many of which had been on other neighboring lakes within the previous 5 days. At least four of these lakes have confirmed cases of Aquatic Invasive Species. Please consider volunteering for this important initiative!
- 3. The Lake District applied for, but did not receive a 3 year (2019-2021) large scale Curly Leaf Pondweed (CLP) treatment grant. The total expense associated with the grant was nearly \$189,000, of which 75% would have been reimbursable back to the Lake District. There is opportunity to resubmit the application in 2020.

Thanks to so many, who have done so much, in making our new Upper Turtle Lake District a vibrant and engaged organization taking control of the quality of our beloved lake!

#### **PROPOSED 2020 BUDGET SCENARIOS**

Two proposed 2020 budgets are below. The expense budgets are identical, with one exception, a \$10,000 line item in the second budget to begin the planning and preparation for another Invasive Species discovery, such as zebra mussels or milfoil.



## Notice: 2019 CLP Management and Treatment Plan

Based upon the studies completed in 2018, the Lake District and its Lake consultants have developed a 2019 CLP treatment plan that begins shortly after the ice is off the lake. The treatment plan targets areas around the lake that have the highest density of CLP. (See map below, the treatment areas are highlighted in green.) As you may remember, CLP is a cold water, early season aquatic invasive species that begins its growth cycle under the ice.

The Lake District will treat approximately 75 acres of CLP in 2019. Aquathol K with the active plant killing ingredient endothal will be applied on 67 acres at 1.25 parts per million (ppm), and 8 acres at 1.50 ppm. The chemical herbicide will be applied from a boat trailing weighted hoses behind it when CLP is only a few inches tall underwater. The chemical treatment of CLP is being administered by Northern Aquatic Services (NAS) of Dresser, WI, under the auidance of our consultant Dave Blumer of LEAPS, and Alex Smith of the WDNR.
