#### July 4th Boat Parade

A big concern that has been brought to the attention of the UTLA Board is Upper Turtle Lake's water quality. Many members have expressed concern about the deteriorating water quality, invasive species potential, and the direct impact water quality has on our property values and the lake recreational quality. We all want a clean lake. We have curly leaf pondweed, an invasive species. This needs to be managed, and the Lake Association has no funds to manage it.

A Lake District is a local government agency designed to manage a lake. It is guided and operated by its members. Lake Districts are the most inclusive form of government that exists in the US. The Lake District board does not make any decisions. The members (the landowners, both residents and non-residents) who attend the Lake District meetings discuss matters, make decisions, and then vote.

Lower Turtle, Echo, Staples, Beaver Dam, Rice, and Horseshoe Lakes, to name a few, all have or are in the process of forming Lake Districts. Lower Turtle has been in existence for almost 30 years, Horseshoe just approved their Lake District last summer, and Echo is in the process of forming a Lake District.

Please come and learn what a Lake District is all about, what it would mean to you, and how we can collectively take a proactive approach to make a positive impact on our lake! Zebra Mussels have been found in Big McKenzie Lake, west of Spooner. Certain water quality criteria are needed to support growth and survival. WDNR researchers have determined that Sand, Upper and Lower Turtle Lakes, Rice Lake, Long Lake, the Vermillions, and Big Trade Lake are all suitable lakes for zebra mussels. Please keep an eye out for this invasive species. The best areas to look for them is to check your structures that are in the water, docks, boat lifts, shorelines, etc.
